Degree applicants are advised to use **ONLINE APPLICATION SYSTEM** through admissions link at www.mocu.ac.tz or osim.mocu.ac.tz and successful applicants will be required to pay TZS 10,000/= as application fee during registration period in October 2017. Applicants who would like to study Certificate and Diploma Programmes at KIZUMBI TEACHING CENTRE IN SHINYANGA and MOSHI CAMPUS FOR SEPTEMBER INTAKE, the deadline for receiving dully filled application forms is 20th August 2017. The New Academic Year 2017/2018 for Certificate and Diploma Programmes is expected to start effectively from 25th September, 2017. For degree programmes the deadline for application is 13th August, 2017 and studies for academic year 2017/2018 will commence not before 30th October 2017.
